

# **SUBMISSIONS**

Biological control for mothplant- please make a submission

A biological control for moth plant is almost here. Moth plant is a fast-growing vine that can rapidly climb and smother trees. Moth plant has white flowers that turn into large hanging kapok-like pods (images attached). It has become increasingly common along roadsides, forest edges and coastal sites in Northland. It is also a problem in urban reserves and gardens where it can spread quickly. Each seed pod splits open to release approximately 750 seeds with silky threads that are carried by the wind to new sites. Moth plant seeds are poisonous and pods and stems contain a milky sap which irritates the skin. Butterflies, moths and bees are attracted to its flowers and become trapped in them, hence the alternative common name of 'cruel plant'.

The Northland Regional Council is applying to the EPA for a species specific rust to be released that attacks moth plant and will help to keep this weed under control.

The NRC needs our help to support their application and submissions are now open – closing on 7 October. Please take this link to make a submission and help get this moth plant control tool approved:


# MPI – Proposed National Environmental Standard for Plantation Forestry


Change of Standard by the MPI not NZ Government to allow the Forestry Industry to plant G E Trees in Northland. What they didn't tell you was this would OVERRRIDE any local council's Bylaws or Resource Consents as they see fit. Thank you and appreciation to Dr Benjamin Pittman for his submission on behalf of the Forest & Bird Northern Branch (see attached), Zelka Grammar from G E Free Northland and David Lourie. I was informed of the meeting late Friday night and attended the MPI Public meeting at Forum North, Whangarei on Tuesday where the staff from MPI were promoting that Forest & Bird supported this new standard. There were 6 MPI Staff which 3 were admin and they had representation from the Forestry Industry (lower north island) and there were no representation from this area Northland. A serious threat where genetically modified trees would be planted alongside local indigenous forests - eg Glenbervie, Russell State Forest - despite the councils in these districts being promoted as GE-Free areas.

The Ministry for Primary Industries (MPI) was seeking public views on the proposed subject matter of a National Environmental Standard for Plantation Forestry (NES-PF). This is a proposal to change how plantation forestry activities are managed under the Resource Management Act 1991 (RMA). If implemented, an NES-PF would replace councils' existing district and regional plan rules for managing plantation forestry. It would provide a nationally consistent approach that is responsive to local environments. Formal consultation will begin on Wednesday 17 June 2015 and closed at 5pm on Tuesday 11 August 2015. A series of public meetings and Hui will be held as part of the consultation. The first one was launched in Wellington and the next first public consultation one was held at Forum North, Whangarei.









# **WDC Draft Rural Urban Interface and Coastal Plan Changes**

Whangarei District Council has prepared two draft plan changes to manage the urban fringe of the city, and the coastal areas of the District. We are now calling for comments on the draft provisions before we progress to a formal notification process toward the end of the year. The Rural Urban Interface (Plan Change 86) considers land on the city fringe that is within the boundary of the Urban Growth Strategy. The proposals include rezoning land that is currently Countryside Environment for urban development (Living 1, 3 and Business 4) based on the Urban Structure Plans. A new zone is also proposed for larger lot residential development that provides for the redevelopment of sites when infrastructure services become available.

The Coastal Environment (Plan Change 87) gives effect to the new Regional Policy Statement which identified the parts of the District that will be classed as the coastal environment. The Regional Policy Statement also identified areas of the coastal environment displaying high or outstanding natural character that require careful management under the New Zealand Coastal Policy Statement. Plan Change 87 proposes to add new overlays to the District Plan Resource Area maps, with related objective policies and rules for subdivision and land use.

# **Environmental Protection Authority) Protection of Environment) Amendment Bill**

Public submissions are now being invited on the Environmental Protection Authority (Protection of Environment) Amendment Bill. The closing date for submissions is Thursday, 10 September 2015.

This bill amends the Environmental Protection Authority Act 2011 to add an additional objective that the organisation must aim to protect, maintain, and enhance New Zealand's environment.

The bill is available online from the 'Related links' panel. The committee requires 2 copies of each submission if made in writing. Those wishing to include any information of a private or personal nature in a submission should first discuss this with the clerk of the committee, as submissions are usually released to the public by the committee.

Those wishing to appear before the committee to speak to their submissions should state this clearly and provide a daytime telephone contact number. To assist with administration please supply your postcode and an email address if you have one.
