## Newsletter June 2023

### Give Nature a chance and she will respond

Before I came to the Kapiti Coast, the Raumati South Residents Association with the help of GW staff began restoring one of QEP's wetlands. When I say "wetlands", it was described to me, by one who was there, as a pond in a farm paddock. This is a 2006 photo from that time taken by Rob Craven. You can see the pond but also the wetland beyond which has manuka and some wetland plants. So, I take it from this that planting was around the wetland and pond. That has protected the wetland and allowed it to recover. Accounts differ so I hope this is reasonably correct.

GW kept it free of weeds and continued to plant around it and Michael has run a trapping line around it until the present day. It looks great and shows little visible signs of once being paddock.

On June 3, I walked through it and heard the unmistakable sound of a fernbird pair. The sound is described as U-tick but to me it sounds like the word "tulip". If fernbirds had been introduced, I would have known, so I am assuming that the birds self-introduced. I have thought for a long time that fernbirds were more mobile than given credit for.

On Saturday, we asked two wildlife photographers to check the hearing out and one returned with photographic evidence. There are fernbirds (one pair anyway) in a QEP wetland.

The internet says fernbirds are *absent from the southern North Island (apart from Waikanae Estuary)* hence the reintroduced birds to Pauatahanui came from Taranaki.

Further, tagged birds have not been found more than 800m from where tagged, but untagged birds have been found 10km from the nearest group.

Now, this is a big deal. It indicates that a wetland that in 2006 was not in great shape and not protected by surrounding bush can now, in less than 20 years, be good enough to let fernbirds self-introduce and because they are largely insectivorous, it indicates the insect life is sufficient for them. This interdunal wetland is like others in QEP we hope to see restored and some are within 800m. That means that QEP could become a significant Wellington habitat for fernbirds. It also means that Kapiti would have two fernbird populations.

Fernbird conservation status is described as At risk / declining so this is an additional reason to restore the wetlands of QEP.

We are not only facing a climate crisis, we are facing a biodiversity crisis where many native species all over the world are declining, becoming vulnerable,

We know restoring QEP to something like its earlier natural state will reduce significant carbon emissions, will allow many forest and wetland plants and animals to recover, will allow its wetlands and forests to sequester large carbon amounts for long periods of time, and will allow plants, birds, lizards and fish, currently not present in the park, to self-introduce.

It will make QEP a more exciting place to visit, a place where we can enjoy nature and maybe see, not just one, but more species that in other places in NZ are at risk. Our first at risk species has arrived.

## Ngā Manu Winter Night Walk

On 10 June 2023 Will Brockelsby from DOC took a small group on a night walk through the Ngā Manu forest to find what critters we could. In spite of it being a frosty night, about 15 of us with headlamps joined the adventure. We saw a number of moths (less than usual because it was so cold), but also saw some other interesting creatures, here's a small selection: A tree frog (not native, but pretty cute), A leaf-veined slug, a dead German wasp (killed by a variety of the *Beauveria* pathogen – that's the white stuff), and in the Top Drain we spotted a Banded Kōkopu (centre) and a kōura (far left).

The subject of his Nga Manu Lecture earlier in the day was about the relationships between Flax, flax weevils, and the *Beauveria* pathogen (seen on the wasp).

#### Emissions Trading settings

The ETS is a government-controlled carbon share trading system that I have commented on before. It is very complex because the objectives are opposed. One objective is to reduce emissions. The other is to protect polluting industry so they do not disappear from NZ. The issue is that we want them to work out ways of operating without producing carbon or else disappear.

Submissions can only be about the settings, not the system itself. If I tried to make any comment on this, I could only say "The settings should drive maximum reduction of carbon and not preserve polluting industries." The
